## FUNERAL HOME SERVICE PACKAGES

Pricing for funeral service packages is less than selecting equivalent services from the individual options which follow. The funeral home service packages include all required professional services, funeral home facilities, equipment, automobiles, and all sundries associated with the service selected as provided by Metropolitan. Fees do not include certified death certificates, casket, urn, burial vault, or the services of outside providers of service or merchandise such as the church, cemetery, crematory, county coroner, newspaper, florist or restaurant.
